

ELIGIBILITY CRITERIA

Nationality Only Indian nationals are eligible to apply.

Essential Educational Qualifications

Candidates must possess a requisite qualification recognized by the NMC erst while **Medical Council of India /NBE** before the last date for submission of application (except for degrees not covered by Medical Council of India, where the degrees must be recognized by the respective bodies that approve the qualifying courses).

Final year appearing candidates may also apply in their respective specialty. However, at the time of joining, passing Degree certificate with registration from the recognized body will be required to be submitted, failing which candidate(s) will not be permitted to join and offer of appointment letter will be cancelled.

APPLICATION PROCEDURE

Important Instructions:

1. If, at any stage, any desired/necessary information is suppressed or misrepresented by the Candidate, his/her candidature can be cancelled and other appropriate action like countervailing etc. can be initiated against him/her.
2. Candidates will have to produce hard copy of their online application, original copies of all certificates in support of all the claims made regarding their candidature in the application and self-attested copies of their certificates, as per the instructions of the institute at the time of interview and/or counseling.
3. Candidates are directed to preserve the information (in the form of soft and hard copy for future reference) rendered at each step of registration/ application (eg registration, fee payment, final submit etc.) while applying online.
4. On-line Application: For online application, candidates will have to provide their mobile number and valid e-mail ID in the prescribed columns, without which their basic registration will not be completed. All the information/instructions will be sent on this mobile number/e-mail id in future.
5. Candidates who are serving in any college/ institution/ hospital as full-time/part-time/under service bond/ect shall obtain a No Objection Certificate form the appropriate authority for application. Their candidature would be rejected if the candidate is unable to produce NOC/ relieving from appropriate authority.

Detailed instructions for filling applications on-line:

The deadline for filling the online form is 10/01/2026 till 1700 hrs. Only those who complete all the steps (pay the fees and complete/ submit the online form by the above deadlines) will be considered.

Filling the application form:

1. Open the home page of Academic Portal of Dr RMLIMS, Lucknow at <https://drrmlims.in>.
2. Online Registration will be open from 27.12.2025 till 10.01.2026 on the Academic Portal of the Institute (<https://drrmlims.in/>).


The following steps are required to fill up the on-line application form:-

Step - 1 (Registration to Create Login)

- Please read all details of advertisement, general instructions carefully before applying.
- Students need to follow the following steps for smooth registration & form submission:
 - logon to <https://drmlims.in/>
 - Click on Single Window System & then get registered by entering details in New Admission batch 2025 section.
 - An OTP will be sent on your registered Mobile No & Email ID.
 - you can set the login password on the same OTP window. After Successful registration proceed to login.

Step - 2 (Login to fill Online Admission Form)

- After Sucessful Registration Applicants may login through Single Sign On system by entering their registered mobile no & set password or through OTP
- On their dashboard they will get the option of Online Admission/Onboardin



- Read the instructions carefully for PDF Certificate Course, tick the disclaimer & proceed
- Complete Part 1 (Applicant Personal details)
- Complete Part 2 (Educational details)
- Complete Part 3 (Documents Uploading Section)
- After completing all the steps, you may submit the form for final submission.
- A SMS containing application number and login ID information will be forwarded at your registered Mobile Number / Email Address.
- Note: Please note down the application number carefully as you need to essentially mention it in all your future correspondence / queries related to your application form.

Check List for online application & interview

- a) Please complete and arrange your application for future references. (No forms or documents to be sent to the Institute)
- b) A self-certified copy of matriculation / age proof certificate.
- c) Proof of MD/MS/ DNB / DM / MCh course recognized by Medical Council of India / State Medical Council and a self-certified MCI recognized MD/MS/ DNB/DM MCh Degree passing certificate. Qualifications from programs where recognition is pending / in process WILL NOT be entertained and no correspondence in this regard will be entertained.
- d) Candidate with medical degree must submit copies of MBBS Medical Registration from Medical Council of India or State Medical Council and also registration of MD/MS/DNB/DM/MCh Degree with council competent bodies.
- e) A 'NO Objection Certificate' from the current employer.(when applicable).

STEPS AFTER SUBMITTING APPLICATION

Date, time and Venue of interview will be notified through E-mail & will be also notified on the website.

Important instructions for interview

The completed Application Form along with relevant certificates should be brought by the candidate on the day of interview for verification.



METHOD OF SELECTION:

PDF Course

No written examination for this post and selection will be based on only through Interview for which intimation will be sent through E-mail.

Candidates have to submit a write-up of about 200 words to describe the work done in the area at the time of interview.

STEPS AFTER SELECTION

Medical examination

No candidate will be permitted to join a course / post, unless declared medically fit by the Medical Board constituted by the Institute for the purpose. The decision of the Board shall be final. With holding information about current or past illness /treatment if discovered at a subsequent stage may result in appropriate disciplinary action that may include termination of appointment at any stage.

Joining

If a candidate fails to join PDF Courses by the date stipulated in the offer of appointment letter, the offer shall automatically stand cancelled and the seat will be offered to candidates in the waiting list in order of merit.

Duties and responsibilities

Students admitted to PDCC/PDF courses shall simultaneously work as Senior Residents. They will be required to perform such work as may be assigned to them and is necessary in the interest of patient care, teaching, training, research and in emergency services as and when required.

Duration of PDF Course: One Year

Salary:

The salary of PDF Candidate's equivalent to 3rd year Senior Resident as admissible in the Institute.



Hostel accommodation

Accommodation may be provided in the campus, if available.

MISCELLANEOUS INSTRUCTIONS

- Date time and Venue of interview will be notified through E-mail & will also be notified on the website.
- No TA/DA shall be paid for appearing in the interview or for joining.
- The number of seats/posts advertised may increase/decrease.
- Number of seats/posts indicated in the advertisement for various programs is provisional and subject to change without prior notice.
- Any attempt on the part of a candidate to suppress facts, to provide false information or to influence selection directly or indirectly will be treated as a disqualification. If evidence of this surfaces after selection, the services may be terminated and admission cancelled, even at that stage.
- Each selected candidate shall have to pay the fee/dues within the prescribed period, failing which his /her admission/appointment shall be cancelled.
- The selected candidates shall need to have present original documents (medical registration, date of birth certificate, certificates of educational qualification, experience and relieving and good conduct certificate from the University/Institution last attended) for inspection and verification by the Institute authorities and submit a self-attested copy of each at the time of joining.



- Qualifications of programs where recognition is pending/ in process will NOT be entertained and no correspondence in this regard will be entertained. Applicants must possess the eligibility degree/ pass certificate before application.
- The MCI/MNC/NBE Registration is mandatory before joining.
- The training programs are full-time and continuous, and private practice in any form after joining the Institute is strictly prohibited. Any violation of this may lead to termination of appointment and cancellation of admission.
- Those who work in departments where there is potential for radiation exposure, shall be compulsorily required to abide by the rules of the Institute's radiation safety cell, (in conformity with the Atomic Energy Regulatory Board guidelines).
- Candidates admitted to PDF Courses in the Institute shall maintain good conduct, attend their classes regularly and abide by the regulations/guidelines of the Institute failing which their names are liable to be struck off the rolls of the Institute.
- Participation in any agitation, protest, strike, etc. is prohibited. Candidates not abiding with the supervisions are liable to be terminated.

Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institute.

- No intimation to non-selected candidates will be sent and no correspondence in this regard will be entertained.
- These rules are subject to change in accordance with the decisions of the Institute, taken from time to time.
- The decisions taken by the Director of the Institute in all matters related to the selection of candidates for admission to various courses shall be final and no appeal shall be entertained on this subject.
